Quick Start enables you to quickly implement the core capabilities of Tripwire Log Center, and introduces you to new features of the current release. This package is also suitable for larger deployments seeking to implement Tripwire Log Center within a subset of their operational environment with the intent of taking ownership of the complete implementation themselves.

Tripwire's Quick Start implementation includes two possible levels of configuration, each of which has several options to choose from to ensure the best match and quickest implementation. Tripwire also offers additional add-on services to best meet your specific needs.

QUICK START, LEVEL 1 DELIVERABLES

- » Installation and configuration complete for up to:
 - 100 assets of up to five types
 - 10 stock correlation rules
 - Five additional Secondary Managers

QUICK START, LEVEL 2 DELIVERABLES

- » Supported hardware must be available to house the Tripwire Log Center Manager and database prior to onsite implementation
- » Asset lists must be provided with the hostname, IP address, and communication method (DCOM, syslog, etc.) prior to onsite implementation
- » Network Devices asset list must be provided that includes IP address, device type and OS, and log type (Syslog, SNMP)
- » Access to AD/LDAP and database nodes to be granted by customer before onsite implementation
